## **NOTICE OF RACE**

### **1. ORGANISING AUTHORITY**

- a. The Organising Authority (OA) will be Club Náutico Punta Lagoa in conjunction with Royal Spanish Sailing Federation (RFEV) and the Galician Sailing Federation (FGV)

### **2. VENUE**

The venue will be Vigo, Pontevedra, SPAIN.

### **3. EVENT GRADING**

The event is an ISAF grade 2 event.

### **4. SCHEDULE**

- a) Race Office opens from 09:00 to 19:00 hours on July 10<sup>th</sup>, 2008.
- b) sailing instructions will be available from 12:00 h. on July 10<sup>th</sup>, 2008
- c) Registration, crew weighting and practice will be from 09:00 to 19:00 hours July 10<sup>th</sup>, 2008.
- d) The welcome ceremony will be at 20:00 hours on July 10<sup>th</sup>, 2008
- e) The first briefing will be at 19:30 hours on July 10<sup>th</sup>, 2008.
- f) The first meeting with the umpires will be immediately following the first briefing.
- g) Racing days will be from July 11<sup>th</sup>-13, 2008.
- h) The time of first race on July 11<sup>th</sup>, 2008 will be 10:00 hours.
- i) The official dinner by organisation will be at 20:00 hours in main tent July 10<sup>th</sup>, 2008.
- j) The Prize Giving will be held at 15:30 hours of July 13<sup>th</sup>, 2008.

k) Unless excused by the organising authority, attendance at the following is mandatory:

1. The morning briefing, for skippers who are racing that day.
2. Social events: Welcome ceremony, Official Dinner and Prize Giving Ceremony.

## 5. SKIPPERS ELIGIBILITY

- a) Maximum twelve skippers will be invited. Only skippers invited by organising authority will be eligible to enter this event.
- b) The designated skipper shall helm the event the yacht at all times while racing, except in an emergency.
- c) Skipper and crew wishing to participate are required to apply to the organising authority for an invitation before May 10<sup>th</sup>, 2008.

## 6. ENTRIES

6.1 The entry documents are as follows:

- The entry form (enclosed)
- A skipper photo (passport size)
- The complete entry form shall be sent before June 20<sup>th</sup>, 2008.

6.2 The team shall be entered on completion of registration, crew weighing, the payment of entry fee, damage deposit and certificate of insurance.

6.3 Entry Fee 500 €. The non refundable fee shall be paid before registration, unless extended by the OA.

6.4 Damage Deposit:

- 6.4.1 When registering for the event skippers shall pay a damage deposit of 300 € to cover damages and loss of equipment that can be attributed to team actions during the event, Credit Cards are not accepted in the Race Office.
- 6.4.2 Any remaining deposit after the event will be refunded at 15:30 hours of July 13<sup>th</sup>, 2008.
- 6.4.3 In the event that organising authority decides a deduction from the damages deposit it may require that deposit be restored to its original amount before the skipper will be permitted to continue in the regatta.

6.5 Insurance:

- 6.5.1 For every competitor team valid and adequate personal certificate of insurance cover shall exist against accident, disability and death covering all the

crewmembers whilst racing (a declarations form from the insurance company must be show it in the registration).

- 6.5.2 A written proof of insurance is required when the team is registered for the event.

#### **a) RULES**

The following rules shall govern the event:

- a) The current ISAF Racing Rules of Sailing (RRS), including Appendix C.
- b) The Notice of Race and its amendments.
- c) The Sailing Instructions (available at registration) and its amendments.
- d) Handling of Boats rules.

### **8. BOATS AND SAILS**

- a) The event will be sailed in TOM 28 boats provided by the organising authority.
- b) The following sails will be provided for each boat:
  - Mainsail
  - Genoa
  - Spinnaker
- c) Boats will be allocated by draw for each round as decided by the race committee.

### **9. CREW (including skipper)**

- a) The number of crew (including the skipper) shall be 5. All registered crew shall sail all races.
- b) The maximum total crew weight determinate before racing shall be 342.5 kg. When the wearing at least shorts and shirts.
- c) When a registered skipper is unable to continue the event the jury may authorise an original crew member to substitute.
- d) When a registered crew member is unable to continue the event the jury may authorise a substitute a temporary substitute or other adjustment.
- e) If any team has less than 5 persons, the organiser will on request assist in finding local Match Race crews to complete the team.

### **10. EVENT FORMAT**

- a) Will be a Round Robin, Semi-final and Final.
- b) Umpiring will be used in accordance with Appendix C of Racing Rules of Sailing
- c) The organising committee may vary the format, finish or eliminate any round, when conditions do not permit the completion of intended format in accordance with APPENDIX C.

### **11. COURSE**

The course will be windward/leeward with starboard rounding and finishing downwind. The regatta will be sailed closest to shore as practicable

### **12. ADVERTISING**

- a) The Organising Authority intend to supply the following equipment ISAF regulation 20.3.2 will apply and Category C advertising as supplied by the OA is to be displayed on this equipment
- b) Competitors may be permitted to display advertising ashore at the venue, but this is subject to individual negotiations with the OA
- c) Boats shall not be permitted the right to protest for breaches of any rules regarding advertising (amends RRS 60.1).

### 13. TROPHIES

a) There will be prizes to the final top three skippers and crews.

The organising authority may require television personnel and equipment (or dummies) to be carried on board while racing and may require competitors to be available for interviews. The organising authority shall have the right to use any images and sounds recorded during the event free of any charge.

### 15. OTHER REQUIREMENTS

Each team is requested to provide on club flag.

### 16. DISCLAIMER

All those taking part in event do so at their own risk. The organising authority, its associates and appointees accept no responsibility for any loss, damage, injury or inconvenience incurred, whoever caused.

### 17. FURTHER INFORMATION

- a) Organising authority will provide accommodation, lunch package and dinner from July 10<sup>th</sup> to 13<sup>th</sup>, 2008.
- b) Transportation from/to Vigo airport, Vigo railway station and Bus Central station will be provided by OA. Other facilities will be offered by organizers at reasonable rates as (physiotherapy, rental car, etc).
